The Petition presented by the Directors of Amtrust International Underwriters Designated Activity Company (hereinafter called the “Transferor”) whose respective names and addresses are set out in the Petition (the “Petitioners”) on the 9<sup>th</sup> day of December 2025 coming on for hearing this day pursuant to the Order made herein on the 17<sup>th</sup> day of December 2025

Whereupon on reading the said Petition and the scheme set out at the Annex to the Petition (the “Scheme”) the Grounding Affidavit of Peter Farrell filed on the 9<sup>th</sup> day of December 2025 the Affidavit of Service of Leanne Ennis filed on the 13<sup>th</sup> day of March 2026 the Supplemental Affidavit of Peter Farrell filed on the 16<sup>th</sup> day of March 2026 and the documents and exhibits referred to in the said Affidavits

And upon hearing Counsel for the Transferor

And there being no attendance in Court by or on behalf of any policyholder employee or any other interested party

And the Court noting the undertaking to the Court given by Counsel on behalf of the Transferor and the Transferee that they shall be bound by the Scheme and shall take all reasonable steps (including the execution of documents) which may be necessary or expedient to give effect to the Scheme

THE COURT DOTH SANCTION pursuant to section 13 of the Assurance Companies Act 1909 (as amended) and Regulation 41 of the European Union (Insurance and Reinsurance) Regulations 2015 (as amended) the Scheme to take effect at 1:01 a.m. (CEST) on the 1<sup>st</sup> day of April 2026 (the “Effective Date”)

AND IT IS FURTHER ORDERED pursuant to section 36 of the Insurance Act 1989 (as amended) that on and from the Effective Date

- i. all Transferring Liabilities (as defined in the Scheme) shall be assumed by and become liabilities of Amtrust Assicurazioni Società Per Azioni (hereinafter the “Transferee”)
- ii. all the rights and powers of the Transferor shall be transferred to the Transferee to the intent and effect that the Transferring Assets (as defined in the Scheme) shall by virtue of the Scheme vest in and form part of the assets

of the Transferee but subject to all Encumbrances (as defined in the Scheme)  
(if any) affecting such Transferring Assets

- iii. all proceedings pending or commenced by or against the Transferor in any court in connection with the Transferring Business shall be continued by or against the Transferee
- iv. the Transferor shall have liberty to transfer to the Transferee all data (including Personal Data as defined in the Scheme) held by or on behalf of the Transferor in relation to the Transferring Business (which includes the Transferring Policies) (as such terms are defined under the Scheme)

AND IT IS FURTHER ORDERED that a copy of this Order be served on the Central Bank of Ireland within 10 days of the perfection hereof
